CHIEF PRESIDING JUDGE'S MESSAGE

King County District Court (KCDC) has seen a lot of changes these past few years, but I am happy to say that we are continuing to meet the challenges we face.

As Presiding Judge, I am committed to improving communication between the court staff and judges, our partner cities, and other branches of government. Over the last few months, I have been visiting each of our District Court locations and meeting with all of our stakeholders across the County to increase communication and discuss the "State of the Court."

Of note in 2023, we were honored to have four new judges join our bench: Judge Karama H. Hawkins (West Division), Judge Andrea S. Jarmon (South Division), Judge Raul Martinez (West Division), and Judge Peter J. Peaquin (East Division). We bade goodbye to Judge E. Rania Rampersad (East Division), who was appointed to King County Superior Court. Congratulations Judge Rampersad!

This past year, our judges continued working to improve the judiciary and the justice system as a whole, both locally and statewide. KCDC judges serve on the District and Municipal Court Judges' Association (DMCJA) and the Board for Judicial Administration(BJA) in various capacities, as well as hold many other regional and state-wide leadership roles. KCDC judges also make time to engage with diverse communities throughout King County, including participating in community events and delivering informative presentations in dozens of venues.

KCDC is now completely caught up from the COVID-19 backlog of cases. I thank all of our wonderful staff members for working so hard to achieve this important public service milestone.

We have also continued to improve our e-filing and case access system for attorneys and the overall public. This includes simplifying our small claims case initiation online; developing an online tool that enables attorneys to more easily identify available calendars; and creating a simplified way to view defendant bookings and releases.

Like all parts of King County government, King County District Court is facing large budget cuts due to shortfalls in the County's General Fund resulting from the state's 1% revenue growth limit on property taxes. At the same time, we know that the criminal justice system is suffering from chronic staffing shortages with attorneys, police officers, corrections officers, and court staff. KCDC is committed to working with others to help make King County a safer and better place to live. For example, our Probation department has taken on a lot of extra work due to staffing cuts the Court had to make in response to reduced budgets.

Our therapeutic courts continue to thrive.
Kenmore joined Community Court in 2023 and
Redmond Community Court celebrated 5 years. In
2024, we look forward to celebrating King County
Regional Mental Health Court's 25th anniversary!

We are very much looking forward to 2024!

COURT SERVICES & LOCATIONS

Summary

King County District Court's 25 elected judges hear a range of civil and criminal cases at locations throughout King County (see map below). The Court is one of the busiest courts in Washington, and is a leader in many areas involving public safety and access to justice.

Services provided

As a court of limited jurisdiction, King County District Court is responsible for the following types of matters:

- · Gross misdemeanor and misdemeanor criminal cases
- Felony first appearance hearings and felony expedited cases
- Protection orders (anti-harassment, stalking, domestic violence, sexual assault, extreme risk-temporary)
- Civil litigation matters (up to \$100,000 per claimant)
- Small claims (up to \$10,000)
- · Name changes
- Search warrants
- Infractions (traffic, non-traffic and parking)
- Other civil matters (vehicle impound hearings, post judgment execution and post judgment enforcement proceedings, petitions for the return of seized animals)

King County District Court also:


- Is contracted to provide municipal court services for 13 cities across the County (see map on page 3)
- Provides judge-supervised probation
- Operates several therapeutic courts, including Regional Mental Health Court, Regional Veterans Court, and Community Courts in Auburn, Redmond and Shoreline-Kenmore
- Accepts applications for U.S. Passports at several courthouse locations

King County District Court Courthouse Locations




CONTRACTING CITIES

Thirteen cities throughout King County contract with King County District Court to provide their municipal court services.





FIVE-YEAR CASELOAD HISTORY




SERVICE ENHANCEMENTS & RESTORATION

In 2023, King County District Court completed several initiatives to enhance access to justice and better serve court users and King County residents.

Small Claims filing simplified

The Court developed an easier way for people to file small claims cases within its e-filing and case access system. Now, people seeking to recover money owed to them can answer a few simple questions online and have the necessary Notice of Small Claim form automatically generated and filed with the Court. The ability to file a Small Claims case is a key judicial service District Court offers to help people resolve disputes. The new guided online interview automates a process that can sometimes seem overwhelming to people who are not familiar with the law or the court system.

Courtroom Calendar Schedule online tool launched

To make it easier for attorneys to find available criminal hearing dates and times in King County District Court, the Court developed a Courtroom Calendar Schedule online tool. Available from the Court's website homepage, the tool provides a simple way to research various criminal hearing types by courtroom across all King County District Court courthouse locations.

Passport acceptance re-started

Following a pause due to the COVID-19 Pandemic, in 2023 King County District Court resumed accepting applications for U.S. Passports. As of March 2024, the public can schedule passport acceptance appointments at the following District Court courthouse locations: Bellevue, Burien, King County Courthouse in downtown Seattle, Maleng Regional Justice Center (MRJC) in Kent, and Shoreline.

Interpreter Program adjustments

King County District Court continues to work with the Administrative Office of the Courts, the Washington State Supreme Court, and the Interpreter and Language Access Commission to provide credentialed and qualified interpreters to court users.

DVMRT (Domestic Violence Moral Reconation Therapy) classes

In 2023, King County District Court completed foundational work to begin offering DVMRT classes in 2024 to people on probation. To help enhance community safety, DVMRT classes focus on moral reasoning and conscious decision-making to help domestic violence perpetrators make better choices. Research by the Washington Supreme Court Gender and Justice Commission (GJC) found that, "in the year following treatment, DV-MRT participants had a significantly lower rate of reconviction for a domestic violence offense than the comparison group (8.4% vs. 12.5%)."

DIVERSITY, EQUITY & INCLUSION (DEI)

King County District Court continues working to create a diverse, engaged court in which a persistent commitment to diversity, inclusion and belonging are core values. The Court's Diversity, Equity and Inclusion (DEI) Committee comprised of judges, directors, managers, court staff and probation staff advanced this cause in many ways in 2023.

Microaggressions awareness training – The Court in 2023 completed foundational work to provide mandatory microaggressions training for all management and staff in the first half of 2024 (judges previously completed part 1 of the training and will complete part 2 in spring 2024). The training helps Court personnel to develop greater sensitivity to the experiences of marginalized groups living in King County.

Customer service survey – To help enhance the Court's service to diverse people throughout the County, the DEI Committee in 2023 undertook scoping to conduct a customer service survey in 2024.

Forms translation – Providing court forms in the many languages King County residents speak, is essential for advancing equitable access to justice. The Court in 2023 completed an inventory of forms that need updated translations and developed an audit process to ensure translated forms are kept current.

THERAPEUTIC COURTS

King County District Court operates several therapeutic courts, including King County Regional Mental Health Court; King County Regional Veterans Court; and Community Courts in Auburn, Redmond and Shoreline-Kenmore. These innovative courts help people address the challenges in their lives that can contribute to criminal behavior. The goal is improved well-being for individuals and a safer King County overall.

Regional Mental Health Court (RMHC)

RMHC's mission is to engage, support and facilitate the sustained stability of individuals with mental health disorders within the criminal justice system, while reducing recidivism and increasing community safety. In 2024, RMHC will celebrate its 25th anniversary of service to the community.

RMHC has been proven to reduce criminal recidivism by 26% and increase participation in substance use disorder treatment by 37 percentage points, according to an in-depth study conducted by the Washington State Dept. of Social and Health Services (DSHS).

2023 RMHC statistics

- * 29 participants graduated from the program
- * 85 active participants were continuing in the program, as of Dec. 31, 2023

Regional Veterans Court (RVC)

King County District Court recognizes that veterans in the justice system may be suffering from post-traumatic stress disorder (PTSD) and other service-related disabilities. RVC seeks to increase effective cooperation between federal, state, and local veterans service agencies and the criminal justice system in order to address the issues that resulted in the veteran being referred to the criminal justice system.

2023 RVC statistics

- * 10 participants graduated from the program
- * 19 active participants were continuing in the program, as of Dec. 31, 2023

Community Courts

Community courts provide services and accountability for people who are eligible and choose to participate. An assessment is conducted for all community court participants to identify their challenges and strengths. The assessment provides information to help determine what follow-up steps an individual community court participant will be required to take, such as community service. King County District Court operates three Community Courts: Auburn, Redmond and Shoreline-Kenmore. Community Resources Centers that are part of each Community Court offer a wide range of social services to community court participants, as well as anyone in the community who needs help.

2023 Community Court highlights

- * City of Kenmore joined Shoreline Community Court, forming Shoreline-Kenmore Community Court
- * Redmond Community Court celebrated its 5th anniversary
- * Auburn Community Court expanded its referrals to include in-custody cases from the South Correctional Entity (SCORE Jail)
- * The Therapeutic Courts Team received a grant for July 2023-June 2024 to assist community court program participants with access to additional services such as food and clothing resources, treatment evaluations, and transportation services. This grant also will allow the team to attend national training through All Rise (formerly NADCP The National Association of Drug Court Professionals) to keep up to date with best practices for therapeutic courts and to help ensure the proper technology is in place to best run the community courts and resource centers.
