



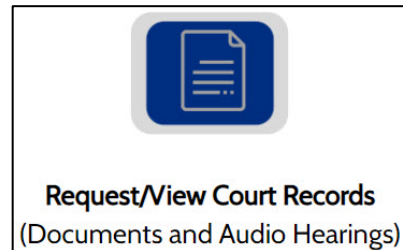

You will be notified via email and through your account once your request is processed. Once submitted, your order status will be available through My Orders.
