3 B) The inquest administrator shall subpoena and examine the involved law
4 enforcement officers in the Butts (Seattle Police Officers Elizabeth Kennedy, Canek
5 Gordillo, Christopher Myers, and Joshua Vaaga) and Lyles (Seattle Police Officers Jason
6 Anderson and Steven McNew) inquests, respectively.

7 3) The Law

8 Enforcement parties' petitions for declaratory relief are hereby granted in part and
9 issued as follows:

10 A) The 2020 EO's provisions that preemptively restricted the testimony
11 of the chief law enforcement officer or involved officers are
12 invalidated.

13 The Superior Court hereby acknowledges the Supreme Court has issued its ruling on all
14 other remaining issues and no further proceedings are necessary in this consolidated matter. No
15 further proceedings being necessary or warranted, this matter is hereby DISMISSED. All parties
16 shall bear their own costs.
