## II. King County Code Text

**2.28.020 Annual executive report required.** The executive shall prepare an annual status report to the council regarding boards and commissions. Such report shall contain, at a minimum, an inventory of boards and commissions; a description of activities; a list of members; a list showing the terms of office, including the terms to expire during the following year; and the department or agency providing staff support, including a contact address and phone number. (Ord. 11319 § 7, 1994)

### III. Executive Summary

Please keep in mind that the number of vacancies is subjective as some boards and commissions choose to function with fewer members than they are allowed to have per their enabling legislation. However, for record keeping purposes, any position not filled is considered vacant.

Terms that expired on, or by, 12/31/2023 are in **bold** print. Terms expiring in calendar year 2024 are shaded gray.

- In mid-November the Boards and Commissions Liaisons requested that each staff liaison providing support to a board or commission, send him a current roster, and a “description of board activities” during 2023.
- The Boards and Commissions Liaison inserted the information provided by the staff liaisons into each board’s draft activity report. The final draft of each activity report was then sent to staff liaisons for final review. The final activity reports were then combined to form the Activity Report section of this report.

#### **Access Paratransit Advisory Committee**

Enabling Legislation: KC Code Section 2.124.010

**Purpose/Mandate:** The Access paratransit advisory committee, which shall advise the Metro transit department, the executive and the council on issues related to Access paratransit relative to the terms of the contract for Access paratransit service. The Access paratransit advisory committee shall have at least nine members who are appointed by the executive and confirmed by the council by motion. Membership shall be comprised of Access paratransit riders, family members of Access paratransit riders, representatives of organizations that provide services to Access paratransit riders and representatives of organizations that support Access paratransit riders or potential riders who have limited English proficiency.

**Total Number of Members:** 11

**Term Length:** 2-year term

#### **Description of Board Activities During 2023:**

- Assisted in broadening the community reach and engagement for Metro’s ADA Transition Plan.
- Helped to improve on-time performance of Access Vehicles through advising on procedure change.
- Discussed future marketing for Access and Access On-Demand services.
- Given ongoing feedback to Metro on continuous improvement of Access Transportation.
- Created committee’s annual report.

#### **Agriculture Commission**

Enabling Legislation: K.C.C. 2.40

**Purpose/Mandate:** The Commission advises the King County Executive and King County Council on agricultural policies and programs, including, but not limited to, existing and proposed legislation and regulations affecting commercial agriculture, land use issues as they impact agriculture, implementation of the livestock ordinance, and ways to maintain, enhance and promote agriculture and agricultural products in the region.

**Total Number of Members:** 15

**Term Length:** 3-year term

#### **Description of Board Activities During 2023:**

- Held 8 meetings in 2023 with a focus on Farmland Preservation.
- Conducted 1 educational field trip to Harvold Berry Farm to learn about elk impacts to crops and deterrents with WA State Department of Fish and Wildlife.
- Advised on King County’s Comprehensive Plan Update; Farm, Fish, Flood; Large events on Farmland in APDs; proposed legislation on Battery Energy Storage Systems (BESS) and increasing the minimum wage in unincorporated King County.

## Agriculture Commission (Continued)

- Included educational presentations on King County Farmland Preservation Policies and Programs, Public Review Draft of the Snoqualmie Valley Agricultural Strategic Plan, Local Food Initiative, proposed legislation, compost use on County-owned Farms.

### Behavioral Health Advisory Board

Enabling Legislation: K.C. Code 2A.300.50

**Purpose/Mandate:** The King County Behavioral Health Advisory Board is mandated by Washington State law to advise King County on the development of plans and policies for the operation of the publicly funded behavioral health system in King County. The board provides policy direction, prioritizes, and advocates for service needs, oversees evaluation of services and provides public information.

**Total number of members:** 9 (the board is comprised of individuals with a variety of lived experiences)

**Term Length:** 3-year term

#### Description of Activities for 2023:

- Recruitment and onboarding of three new board members: Nathan Gordon, Kevin Host and Mustafa Mohammed.
  - In January 2023, created plan for internal and external presentations for the year to present on Behavioral Health and Recovery programs and services available throughout King County.
  - Continued recruitment, to ensure we meet minimum board member requirement especially for those districts that are underrepresented and to meet the bylaws currently being updated in regard to the Crisis Care Center Levy that was passed by King County voters April 2023.

### Board for Developmental Disabilities

Enabling Legislation: K.C. Code 46.38.0500

**Purpose/Mandate:** The Board for Developmental Disabilities provides oversight of community services for residents of the County who have developmental disabilities such as cerebral palsy, autism, Down syndrome, or other neurological impairments, and their families. The Board develops plans, makes recommendations on the use of available funds, and advocates for increases in state funding and improvements in services.

**Total number of members:** 15

**Term Length:** 3-year term

#### Description of Activities for 2023:

- Moved to Hybrid Board Meetings: In 2023, the Board moved to Hybrid meetings to give community members a choice of meeting in-person or via the web. Meeting times were moved to the late afternoon/early evening to make meetings more accessible to community members who work during the day.

## Board for Developmental Disabilities (Continued)

- Board Sponsored Events: The Board held two in-person community events in 2023 to provide resources and information to members of the developmental disabilities' community. The first event: Caregivers Supports, Life After High-School, was held in March 2023. The second event, Adulthood with Attention-Deficit/ Hyperactivity Disorder, was held in August 2023.
- Recognition of Intellectual and Developmental Disabilities Month: Members of the Board provided input on a proclamation issued by the County Executive in recognition of March 2023 being Developmental Disabilities Awareness Month.
- Monthly Board Newsletter: To increase community connections and information sharing, the Board began distributing a monthly newsletter about upcoming Board meetings, events and community information related to developmental disabilities in 2023.
- Board Recruitment: The Board focused on recruitment in 2023 through outreach and engagement at Board meetings, events, and through newsletters. After several years of declining Board membership during COVID, the Board added three new members in 2023 as it implemented strategies to further increase Board membership.

## Board of Appeals and Equalization

Enabling Legislation: RCW 84.48; enabled by Home Rule Charter under the Board of Appeals, Article III, Section 340.40 and 340.60; Article VII and the King County Code, Section 2.34

**The Board of Appeals and Equalization is an “Independent” board and therefore is exempt from completing the “Description of Board Activities During 2023” sections of this report.**

**Purpose/Mandate:** The Board of Appeals and Equalization (BoAE) is an independent body organized to hold quasi-judicial hearings to adjudicate appeals on determinations made by the Department of Assessments or, by council ordinance, any order issued by an executive department or administrative office.

**Total Number of Members:** 7 members

**Term Length:** 4-year term

## Board of Ethics

**Enabling Legislation:** K.C.C. 3.04

**Purpose/Mandate:** To ensure proper implementation and interpretation of the Code of Ethics. The board's mission is to ensure the highest standards of public service by developing, disseminating, and promoting readily understandable ethics requirements for King County employees and agencies. Its first goal is to educate elected officials, county employees, and board and commission members about their obligations to the public under the Code of Ethics. The ethics education program underscores the belief that ethics is a positive tool with which to support both good management practices and good public service on behalf of the citizens of King County.

## Board of Ethics (Continued)

**Total Number of Members:** 5 (2 Council at-large representatives; 2 Executive at-large representatives; and 1 board-nominated representative)

**Term Length:** 3-year terms

### Description of Board Activities During 2023:

- Member Laura Crandall was appointed to the King County Board of Ethics, filling an executive-nominated position.
- Members Michael Blake and Bruce Davis were reappointed to the King County Board of Ethics, filling council-nominated and executive-nominated positions, respectively.
- Received Public Records Act and Open Public Meetings Training.
- Provided feedback to proposed changes by the King County Council, leading to amendments in the Code of Ethics sections related to the early resolution process and actions the Board can take during investigations and appeals.
- Conducted three board of ethics meetings.
- Decided that its next project will be to update the Board of Ethics Procedures for Meetings document and participate in the discussion and work relating to the amending King County Code Section 3.04. It will take on this work in 2024.

## Children and Youth Advisory Board

**Enabling Legislation:** K.C.C. 2A.300.510

**Purpose/Mandate:** The King County Children and Youth Advisory Board will assist King County in making King County a place where all children and youth have the opportunity to achieve their full potential. The board is guided by this vision, which is enshrined in the King County Strategic Plan and is central to King County's Equity & Social Justice work and the work occurring under the adopted Health & Human Services Transformation Plan. In addition, the board is guided by King County's adopted Youth Action Plan, which describes a path for unlocking the full potential of our children. The primary function of the CYAB is to serve as the oversight and advisory board for the Best Starts for Kids Initiative, the King County Youth Action Plan, and the Puget Sound Taxpayer Accountability Account.

**Total Number of Members:** Up to 40 members

**Term Length:** 3-years

### Description of Board Activities During 2023:

- Advisory body to the Puget Sound Taxpayer Accountability Account, providing public oversight to PSTAA related funds (e.g., ELF General Child Fund, Family Care Facilities Fund, and King County Promise investments).
- Participation and support of Care & Closure work around the repurposing and closing of the youth detention facilities in King County.
- Issued an advisory request to King County Executive asking the county to prioritize the renewal of the King County Youth Action Plan.

## Children and Youth Advisory Board (Continued)

- Attended the Best Starts for Kids 2023 Summit and hosted an information table throughout the week. Also, participated in a radio interview to promote the work of the CYAB and recruit diverse members.
- Participated in a two-part authentic youth partnership training to improve youth collaboration and future engagement.
- Supported and promoted the work of the King County Youth Bill of Rights project.
- Continued collaboration with Juvenile Detention Services to address culture, census, and service delivery at the youth jail.
- Provided feedback and review on the Best Starts for Kids Annual report as required by legislation.
- Served on RFX review panels for several BSK investment areas and funds.

## Civic Television Citizens Advisory Committee

Enabling Legislation: K.C.C. 2.59.110

**Purpose/Mandate:** The CTV Citizens Advisory Committee develops policies and procedures and oversees the operation of the King County government access channel C-TV. Each board member is appointed to represent a different sector of the communications industry that includes broadcast, public relations, print media and social media/internet. Members are compensated at \$50.00 per diem per day when attending to Committee business.

**Total Number of Members:** 4 members

**Term Length:** 4-year terms

### Description of Board Activities During 2023:

- King County Television (KCTV) completed work on a new Cablecast Playback Automation System. This replaces an outdated 10-year-old system and now allows for full captioning. The security component has been greatly upgraded and Video on Demand (VOD) can be accessed from the KCTV website. The new system is set to be fully activated by January 2024 after staff has had sufficient time to do testing.
- Staff continued to widen King County's exposure with social media outlets. Coverage for our Council meetings, news and County area specific pieces received much more coverage this year. Citizens who do not have cable TV have the ability to "stream" content through several media apps that link to the KCTV website. Streaming numbers for many King County events were as high as 500-600 per event.
- The King County Sheriff's Office continues a strategic partnership with KCTV with videos highlighting those areas of incorporated King County who contract with our Sheriff's Office for service. KCTV also covered the works of many other agencies and local groups including Environmental Quality Research, Homelessness, Black History Month, local sporting events, and a series on the King County bi-annual budget; "How do citizens contribute to the funds needed to operate King County government"?

## **Civic Television Citizens Advisory Committee (Continued)**

- For 2024 staff will again concentrate on broadening and adding more coverage in providing information for immigrant groups as King County continues to see its immigrant population greatly increase. Currently KCTV assists the King County Health Department with resources and studio space to produce multi-language videos for immigrants.
  - KCTV won 10 Programming Awards from national NATOA that included one series highlighting Public Affairs and one on the issue of Homelessness.

### **Civil Service Commission**

**Enabling Legislation:** RCW 41.14 / KCC 3.14

**Purpose/Mandate:** The Civil Service Commission is an important but seldom used quasi-judicial body with impartial review authority over disciplinary matters in the King County Sheriff's Office. The Civil Service Commission is distinct from the King County Personnel Board and its creation is in accordance with RCW 41.14. The Commission is responsible for hearing appeals related to the removal, suspension, demotion, or discharge of an employee in the King County Sheriff's Office classified civil service.

**Total number of members:** 3

**Term Length:** 6-years

**Description of Board Activities During 2023:**

- The Civil Service Commission did not meet in 2023.
  - There were no appeals or business brought to the Civil Service Commission in 2023.

### **Communities of Opportunity-Best Starts for Kids Levy Advisory Board**

**Enabling Legislation:** KCC Section 2.A.300.520

**Purpose/Mandate:** The Communities of Opportunity-Best Starts for Kids Advisory Board provides leadership and assistance to King County to create greater health, social, economic, and racial equity in King County so that all people thrive and prosper, regardless of race or place. The board is guided by this vision, which is central to King County's Equity & Social Justice work. COO was originally created through a partnership between Seattle Foundation and King County in 2014. The governance body established for the COO partnership has taken on functions of acting as the advisory board for the COO element of the Best Starts for Kids (BSK) levy, providing oversight and advice to King County, consistent with the council adopted BSK implementation plan and legislation.

**Total Number of Members:** Minimum of 20 members and a maximum of 24 members

**Term Length:** 1 to 3-years

## Communities of Opportunity-Best Starts for Kids Levy Advisory Board (Continued)

### Major Achievements in 2023:

- Recruited and nominated and (re)appointed 16 members of the advisory board.
  - Participated in a two-day in-person retreat, to better ground and align COO's values and roles as an advisory board. (February).
  - Reviewed and approved the Request for Proposal (RFP) process and recommended awarding funding to nine Community Partnership Proposals and nineteen Systems and Policy Change (SPC) contracts. SPC contracts are administered by Seattle Foundation for 2023-25. (Jan-February).
  - Supported and provided feedback advised on the hiring process of the Interim COO director (April-May).
  - Reviewed and discussed COO's core concepts, including COO's theory of change and major past funding accomplishments. (July, August, September, October).
  - Provided guidance and input in the 2023-24 Workplan developed in collaboration with Interim Director. This workplan outlines the goals and objectives of the advisory group through the end of 2024. (Workplan developed in September 2023).

### Community Advisory Committee on Law Enforcement Oversight

Enabling Legislation: K.C.C. 2.36.050

**Purpose/Mandate:** The Community Advisory Committee provides input and guidance on policies, procedures and practices relating to policing in King County. This includes conducting outreach to communities served by the Sheriff's Office, gathering information about public perceptions and concerns relating to the Sheriff's Office, and providing the public with information about recourse for alleged police misconduct. This outreach should increase accountability and public understanding of the misconduct and discipline policies, procedures, and practices of the Sheriff's Office and other issues related to OLEO's responsibilities. The Community Advisory Committee on Law Enforcement shall:

1. Serve as a liaison between the office of law enforcement oversight and the communities it serves.
2. Advise the office of law enforcement on systemic problems and opportunities to improve law enforcement training, policies, and practices.
3. Advise the sheriff's office and the council on matters of equity and social justice related to law enforcement including opportunities to reduce criminal justice involvement, decrease recidivism, abate inequities, and enhance fairness in the justice system.
4. Advise the sheriff and the council on systemic problems and opportunities for improvement in the law enforcement practices of the sheriff's office.

## Conservation Futures Advisory Committee

Enabling Legislation: KCC 2.36.070

**Purpose/Mandate:** The King County Conservation Futures tax (CFT) levy is a dedicated portion of property taxes collected throughout the county and its cities. CFT collections are used by King County and the cities to purchase urban and rural open space. King County Ordinance 14714 directs the Conservation Futures Advisory Committee to make recommendations on the funding allocations for CFT projects. The Committee conducts an annual review of applications for CFT funding and for King County Parks open space funding and recommends funding allocations to the King County Council and Executive. The Committee also conducts a project progress review of older awards, approving scope changes and recommending funding reallocations between projects. Projects funded with CFT must have dollar-for-dollar matching funds, which leverages the benefits of the program, unless projects are located in opportunity areas and receive a match waiver.

**Total number of members:** 16 (9 Council-nominated positions; 4 Council at-large representatives; and 3 Executive at-large representatives)

**Term Length:** 4 years

### Description of Board Activities During 2023:

- The Committee continued its work in the fifth year of accelerated funding to implement the Land Conservation Initiative, accelerating the pace of conservation in King County. The voters of King County approved restoring the historic collection rate in November 2022 with 70% approval, increasing collections starting in 2023. King County adopted major policy changes in summer 2023 affecting the Conservation Futures program, reducing the required match from 50% to 25% of total project costs.
  - These changes enable the Committee to recommend \$109 million in Conservation Futures and Parks Levy county open space funding at the new 25% match level (a major increase over the \$67 million that was recommended at the 50% match level).
  - The Committee recommended funding for \$12 million to opportunity area projects for underserved communities, including nonprofit-led farmland access acquisitions for historically underserved populations.
  - The Committee collaborated with the county to revise the grant schedule starting in 2024, to better distribute the timing and funding opportunities available across the year.
  - One new member was appointed in 2023; Council has been recruiting for one new member; and four positions are awaiting reappointment in 2023.

## Cultural Development Authority (4Culture)

Enabling Legislation: K.C.C Section 2.49

**The Cultural Development Authority (4Culture) is considered an “Independent” board and therefore is exempt from completing the “Description of Board Activities in 2023” section.**

**Purpose/Mandate:** A 15-member Board of Directors governs 4Culture, with individuals representing the broad cultural, geographic, and ethnic diversity of King County, as well as backgrounds in arts, heritage, historic preservation, and public art, finance, tourism, education, real estate, and government relations. 4Culture Board members are primarily responsible for organizational financial oversight; securing and maintaining resources from all levels of government; advocacy, especially regarding resources; setting policy relevant to the organization as a whole; and serving as the public face of 4Culture. 4Culture's Board also looks at cross cutting or timely issues that could impact 4Culture and coordinates and leads responses. It also provides official approval of all grant recommendations, which are forwarded from the three Advisory Committees that oversee funding programs.

**Term Length:** 3-year terms

## Deferred Compensation Plan Board

Enabling Legislation: Executive Policy PER 10-31 (AEP)

**Purpose/Mandate:** The King County Employees Deferred Compensation Plan Board oversees the operation of the County's deferred compensation program on behalf of the County and Plan participants. The board is comprised of nine members, which includes four participant representatives, three Ex-Officio members, one Council representative and one Executive representative. Members serve three-year terms with no term limit. Members must be participants in the Plan. Employee representatives must demonstrate ability to work with diverse groups to accomplish complex tasks. Experience with managing financial programs is a desired qualification. The Membership Committee Chair nominates prospective board members, and the board confirms the appointment. No Executive appointment or Council confirmation required.

**Total Number of Members:** 9 members

**Term Length:** N/A

### Description of Board Activities During 2023:

- The board held 8 board meetings.
- The board is starting an RFP process for a third party admittatur for the deferred compensation plan.
- The board approved four resolutions:
  - A resolution to increase the automatic increase contribution cap from 5% to 15% of annual compensation and to direct the plan administrator to take all steps necessary to implement the change.
  - A resolution to update options available through the Plan Trading Menu for self-directed brokerage accounts.

**Purpose/Mandate:** To review and make recommendations regarding EEO and AA strategies, systems, policies and guidelines; reviewing the EEO/Affirmative Action Plan and updates with the Department of Human Resources; making recommendations regarding the Plan's adoption to the King County Executive, and reviewing semi-annual and annual Affirmative Action progress reports, as well as advising the County Executive accordingly. The Committee has 22 representatives (each King County Department will have one representative per 1,000 regular employees). Members serve 3-year terms and must be King County employees.

**Total Number of Members:** 18 Department Representatives

**Term Length:** 3-Years

### Describe the Board's Activities During 2023:

## Emergency Management Advisory Committee

**Enabling Legislation:** K.C.C. Section 2A.310.050

**Purpose/Mandate:** The Emergency Management Advisory Committee (EMAC) was originally formed in 1993 and established by ordinance in 1999. The EMAC acts in an advisory capacity to the King County executive, council, and office of emergency management, on emergency management matters and facilitates the coordination of regional emergency planning in King County.

**Total number of members:** 52 (primary and alternate representatives)

**Term Length:** 3-Years

### Description of Board Activities During 2023:

- Set new priorities for the committee through breakouts and brainstorming, all of which are still being worked on by members of this committee through multiple outlets. The priorities included sheltering, EOC interoperability, Mutual Aid, and Debris Management.
  - Reviewed and re-established workgroups under the committee that are meeting regularly. The two new established workgroups are Executive Communication & Public Policy and Regional Coordination.
  - Participated in the SHSP grant cycle, bringing in \$1,250,000 to King County.
  - Met in person regularly for the first time post-COVID and participated in a committee level TTX (tabletop exercise) around elections security during a CCTA (complex coordinated terrorist attack) scenario.

**Purpose/Mandate:** The purposes of the Employee Charitable Campaign Committee (dba Employee Giving Program Committee), prescribed in K.C.C. 3.36.030, are to:

- Recommend rules consistent with K.C.C. Chapter 3.36 to the council as necessary.
- Coordinate the Employee Giving Program, such coordination may include:
  - Determining which federations of charitable organizations may, consistent with this chapter and any rules adopted pursuant to it, participate in the county's giving program and the dates by which applications must be filed for the annual campaign.

**Fauntleroy Ferry Advisory Committee**  
**Enabling Legislation:** RCW 47.60.310

**The Fauntleroy Ferry Advisory Committee is an “Independent” board and therefore is exempt from completing the “Description of Board Activities During 2023” section of this report.**

**Purpose/Mandate:** The Ferry Advisory Committee reports to the Washington State Department of Transportation (DOT) and reports on problems experienced within the area served by the Washington State Ferries, particularly when the DOT is conducting a review of the tariffs and other ferry service questions. The Fauntleroy FAC represents the residents and business groups of West Seattle pertaining to Washington State Ferries operations through the Fauntleroy Ferry Terminal. This includes advising or informing WSF management of issues and concerns relating to sailing schedules, ferry operation, and community interests. The Committee is comprised of 3 members serving 4-year terms. Members are frequently asked to represent ferry patrons by serving on Ferry Planning Committees. At the time of appointment, not more than two members shall be from the same political party.

**Term Length:** 3-years

**Harborview Medical Center Board of Trustees**  
**Enabling Legislation:** K.C.C. Section 2.42

**The Harborview Medical Center Board of Trustees is an “Independent” board and therefore is exempt from completing the “Description of Board Activities During 2023” sections of this report.**

**Purpose/Mandate:** The Board, as the representative authority of King County, oversees the provision of health-care services to assure that high quality health care is made available to King County residents.

**Total number of members:** 13 (9 Council-nominated representatives; and 4 Council at-large representatives)

**Term Length:** 4-year term (3 consecutive term limit)

**Health Through Housing Advisory Committee**  
**Enabling Legislation:** KC Code: 2A.300.200

**Purpose/Mandate:** The Committee will advise the King County Executive and the King County Council on matters affecting the HtH initiative; advise the King County Department of Community and Human Services on implementation of the HtH initiative; review performance data on the HtH initiative; and report annually to the King County Council and the community on the expenditures, accomplishments, and effectiveness of the HtH initiative.

**Total number of members:** Between 12 and 16 members

**Term Length:** 2-4year term

## Health Through Housing Advisory Committee (Continued)

### Description of Board Activities During 2023:

- In May 2023, the King County Council and County Executive leadership approved 14 candidates from diverse geographic regions of King County to become members of the HTH Advisory Committee.

The Commission will support refugees and immigrants to thrive and succeed while maintaining their own identities.

**Term Length:** 3-year term

### Description of Board Activities During 2023:

- KCIRC Hosted 11 Meetings and IRC offered in-person options for community members to attend and provide public comment per OPMA.

The Roundtable is comprised of 16 members representing various communities or agencies.

**Term Length:** 3-year term

**Description of Board Activities During 2023:**

- KCIA Equity and Social Justice Town Hall with Roundtable volunteer and Community members on the panel.
- Achieved Level 2 in the Airports Council International (ACI) Airport Carbon Accreditation Program (ACAP).
- In July, we held the annual Foreign Objects and Debris (FOD) Walk with airport staff and community volunteers. The FOD Walk is held annually in July. Everyone gets out on the airfield and walks shoulder to shoulder to look for any objects on the runway that could be caught in an airplane's engine. This event is usually attended by over 100 volunteers. We do this before the Blue Angles fly in for Seafair week.

**King County Housing Authority Board of Commissioners**  
**Enabling Legislation:** RCW 35.82.040

**The King County Housing Authority Board of Commissioners is considered an “Independent” board and therefore is exempt from completing the “Description of Board Activities During 2023” sections of this report.**

**Purpose/Mandate:** The King County Housing Authority (KCHA) is responsible for administering Federal public housing and Section 8 programs and a broad range of other housing and services for low-income households in incorporated and unincorporated King County - outside of the cities of Seattle and Renton. The Authority presently owns or controls 11,150 units of housing and provides rental subsidies to over 10,118 additional households through its Section 8 voucher program.

**King County Library System Board of Directors**  
**Enabling Legislation:** RCW 27.12.30

**Purpose/Mandate:** The King County Library System is a separate entity from King County government. King County has no oversight of the day-to-day operations of KCLS. However, in accordance with RCW 27.12, King County is responsible for appointing the seven members of the Board of Trustees. The KCLS Board is responsible for the governance of the King County Rural Library District, an independent taxing district serving residents of King County and other unincorporated areas of the county. It is responsible for the adoption of policies, bylaws, rules, and regulations, as well as approval of both the annual operating budget and wages and benefits for more than 1,300 staff. The Board hires the Executive Director and conducts an annual performance review.

**Lake Geneva Management District Advisory Board**  
**Enabling Legislation:** RCW 36.61.100 and KC Ordinance 18282

**Purpose/Mandate:** The King County Lake Geneva Management District Advisory Board was created in 2016 to allow the district to immediately begin operations, create a work program and obtain funding for its work program. The boundaries of the district include all lakeside parcels to Lake Geneva. The duration of the district shall be from 2016 through 2026.

**Description of Board Activities During 2023:**

- The district had 2 advisory board meetings.
  - District performed 1 vegetation survey at the lake.

**Purpose/Mandate:** The Museum of Flight Authority Board of Directors established to govern the affairs of the public authority. The directors shall be appointed and serve their terms as provided in the charter. All corporate powers of the public authority shall be exercised by or under the authority of the board of directors; and the business, property and affairs of the authority shall be managed under the direction of the board of directors, except as may be otherwise provided for by law or in the charter.

## Noxious Weed Control Board

Enabling Legislation: State RCW 17.10

**Purpose/Mandate:** The King County Noxious Weed Control Board sets the county noxious weed control priorities and budgets, annually adopts the noxious weed list, and administers the Noxious Weed Control Program throughout the county according to the requirements of RCW 17.10. The Board, which has regulatory authority, represents the people of the county. The primary mission of the weed board is to educate landowners to be responsible stewards of the land and resources of King County by protecting and preserving all lands and natural resources of the county from the degrading impact of invasive noxious weeds; and to provide quality, timely and responsive service to the residents of King County.

**Total Number of Members:** 5

**Term Length:** 3-years

### Description of Board Activities During 2023:

- Sets the county noxious weed control priorities.
  - Oversees the allocation of resources in 2022/23 program budget.
  - Adopts the King County Noxious Weed Control list.
  - Administers the Noxious Weed Control Program throughout the county according to the requirements of RCW 17.10.
  - Educate landowners to be responsible stewards of the land and resources of King County by protecting and preserving all lands and natural resources of the county from the degrading impact of invasive noxious weeds; and to provide quality, timely and responsive service to the residents of King County.

**Parks Levy Oversight Board**  
**Enabling Legislation:** K.C. Code 7.08.090

**Purpose/Mandate:** The mission of the Parks Levy Oversight Board is to review the Parks and Recreation Division's expenditures of the 2020 - 2025 King County Parks, Recreation, Trails, and Open Space Levy to confirm that the levy was spent in compliance with the levy ordinance.

**Total Number of Members:** 9 members (9 Council district representatives)

**Term Length:** Through the duration of the current levy

**Description of Board Activities During 2023:**

- Meeting of the Parks Levy Oversight Board on September 13, 2023 (Weyerhaeuser King County Aquatic Center). Topics included overview of the Board, mid-levy progress report, parks levy financials, operations and maintenance, community partnerships, and levy grants.
  - Meeting of the Parks Levy Oversight Board on September 27, 2023 (Jim Ellis Preston Community Center). Topics included King County Parks Capital Improvement Program, King County Strategic Climate Action Plan, and King County Parks Equity Action Plan.
  - Meeting of the Parks Levy Oversight Board on October 12, 2023 (Woodland Park Zoo). Topics included pass-through funding to towns and cities, the Seattle Aquarium, and the Woodland Park Zoo.
  - Finalized the annual Board report (*Review of 2022 Expenditures of the 2020-2025 Parks Levy*) on October 12, 2023.

**Personnel Board**

**Enabling Legislation:** King County Charter – Article 5, Section 540

**Purpose/Mandate:** The King County Personnel Board was created by the County Charter (See Article 5, Section 540) for the purpose of hearing and deciding certain kinds of appeals from County employees who are members of the Career Service and choose not to pursue a grievance procedure under an applicable bargaining agreement, if any. Board members receive a per diem of \$100 for all day board work; \$75 for official board work of three hours or less; an additional \$25 per day is paid to the chair of the board during any full day (six hours or more) or \$13 for work of three hours or less in which board business is conducted.

**Total Number of Members:** 5 (including 1 Career Service elected representative)

**Term Length:** 5-year terms

**Description of Board Activities During 2023:**

- In 2023, eleven active appeals were before the Board: nine reclassification appeals (including three separate group classification appeals involving multiple appellants) and two termination appeals (including a consolidated termination appeal).
- Of the eleven active appeals, the Board issued nine decisions (four orders denying appeal; five orders dismissing appeal) and scheduled pre-hearing conferences for the two remaining reclassification cases.

## Personnel Board (Continued)

- The Board created a website to make information about the Board and the appeal process more accessible.
  - The Board submitted legislation changes to update K.C.C. 3.08.120 and 3.08.110.
  - The Board convened numerous times over the course of the year to conduct pre-hearing conferences, status conferences, evidentiary hearings, deliberations on completed hearings, and to consider and decide various motions.
  - The Board completed the above activities with a reduced number of members, while experiencing the retirement of long-serving legal support and transitioning to a new form of support.

### **Public Defense Advisory Board** **Enabling Legislation:** KC Code 2.60.031

**Purpose/Mandate:** The board regularly reviews the activities and plans of the Department of Public Defense, makes recommendations to the county public defender on matters concerning the department, advises the executive and council on matters of equity and social justice related to public defense, and prepares the reports required by the enabling legislation and such other reports as the board may deem appropriate. The Board is comprised of 11 members serving three-year terms. The Board meets at least once every two months. Board members are not compensated but may be reimbursed for parking expenses in the King County parking garage when attending meetings of the committee.

**Total Number of Members:** 11

**Term Length:** 3 years

#### **Description of Board Activities During 2023:**

- Completed the Board's annual report on the state of public defense in King County.
  - Received bi-monthly updates from the Department on caseload and filing trends.
  - Filled the Board's sole vacancy this year with an outstanding member of the immigrant rights advocacy community.
  - Advised on the Department's advocacy efforts for adoption of new caseload standards pursuant to a ground-breaking study from the American Bar Association.
  - Provided a forum for feedback on the state of public defense from the public.

### **Rural Forest Commission** **Enabling Legislation:** KC Code: 2.41

**Purpose/Mandate:** The Commission advises the Executive and Council in their efforts to encourage forestry in the rural areas of the County. The commission applies this mandate to make forestry viable in King County's rural areas by supporting forest management on private and County-owned lands.

**Total Number of Members:** 13 members

**Term Length:** 3-years

### Description of Board Activities During 2023:

  - Reviewed KC 2024 PRD Comprehensive Plan and submitted memo focused on areas of concern.
  - Submitted letter requesting BMP consideration for fire resilient landscaping actions to KC Executive and KCC.

## Seattle Transitional Grant Area HIV Planning Council

**Enabling Legislation:** Federal--Ryan White Comprehensive AIDS Resources Emergency Act of 1990, most recently reauthorized as the Ryan White HIV/AIDS Treatment Extension Act of 2009

**Purpose/Mandate:** The Seattle Transitional Grant Area (TGA) HIV Planning Council is a requirement of the federal Ryan White Act, which also funds its activities. The Council has the responsibility to assess the need for care services for people living with HIV (PLWH) in King, Snohomish, and Island Counties, and to identify gaps in services not covered by other programs. It then allocates over \$6 million per year in Ryan White Part A funds to fill the gaps in those services. The Council also has a variety of other responsibilities including comprehensive planning, assessing administrative mechanisms related to the contract process, and following federal rules related to membership and processes. The Planning Council is comprised of up to 40 members serving 3-year terms.

**Total Number of Members:** Up to 40

**Term Length:** 3-years

### Description of Board Activities During 2023:

- As part of its three-year plan, the Planning Council started planning its focus/emerging population needs assessment. The assessment will focus on the aging population of people living with HIV. The Planning Council will utilize findings from its needs assessment to inform its Priority Setting and Resource Allocation process in 2024.
- The Council participated in the following trainings in 2023:
  - Housing in the Transitional Grant Area

## Seattle Transitional Grant Area HIV Planning Council (Continued)

- The Council conducted an assessment of the administrative mechanism, as required by the Council's grantor. The Council analyzed the Recipient's contracting and reimbursement process to ensure that contracting and reimbursements happened in a timely manner.
  - The +Caucus, a committee of the Council made up of people living with HIV, held a spring and summer recruitment event.
  - The Council completed deliverables required by the Ryan White Part A grant including but not limited to reallocation of funds, request of carryover funds, and writing the Council's section in the Non-Compete Continuation application.
  - The Council recruited three new members in 2023.

### Solid Waste Advisory Committee

**Enabling Legislation:** RCW 70.95.165; KC Code 10.28

**Purpose/Mandate:** The Solid Waste Advisory Committee (SWAC) is an advisory body that is required under Washington State law (RCW 70.95.165) and created in King County Code 10.28. The committee provides input on solid waste management issues and policies that affect county residents and the services they receive. The committee is balanced geographically and includes recipients of solid waste services, representatives from public interest groups, labor, waste management industry, manufacturers located in King County, local elected officials and recycling and marketing interests. The Committee is comprised of up to 20 members serving 3-year terms.

**Total Number of Members:** 18 members

**Term Length:** 3-years

#### Description of Board Activities During 2023:

- Committee met monthly to discuss and advocate for solid waste related policies internally and externally.
  - Continued to stay updated on key capital and pilot projects.
  - Discussed significant policy and plan updates that will be forthcoming in 2024-2025.
  - Received updates on the Seattle – KC Residuals ILA process and agreement.
  - Had regular check-ins with the new rate structure that takes effect January 1, 2024.

### Transit Advisory Commission

**Enabling Legislation:** KC Code 2.124.010

**Purpose/Mandate:** The King County Transit Advisory Commission improves transit services, planning, and programs by advising Metro's staff members and general manager, the King County Executive and Council, local jurisdictions, and subarea transportation boards concerning transit policy issues. The commission's role is to: advise Metro on the inception and development of long-range planning efforts; advise Metro and King County on issues essential to transit service in King County, including matters of concern to the elderly and persons with disabilities; and serve as a resource for inter-jurisdictional transit promotion and coordination. The Commission is comprised of 18 members serving 2-year terms.

## Transit Advisory Commission (Continued)

**Total Number of Members:** 18

**Term Length:** 2-years

### **Description of Board Activities During 2023:**

- Met nine times in 2023 to discuss Metro programming and provide feedback.
  - Completed membership recruitment for 2023.
  - Recruited 6 new members and re-appointed 3 members, totaling membership to 10.
  - Had a TAC Meet & Greet for new and returning member.

## Vashon-Maury Island Groundwater Protection Committee

**Enabling Legislation:** KC Code 9.14.070

**Purpose/Mandate:** The Vashon-Maury Island Groundwater Protection Committee is tasked with tracking and advising on the protection of groundwater resources. Specific responsibilities include advising the King County Executive and Council on Groundwater issues; monitoring, participating in and advising County elected officials, special purpose districts, water and sewer utilities, and water purveyors on implementation of the Vashon - Maury Island Ground Water Management Plan (GWMP); making policy and program recommendations to support the protection of groundwater resources; and coordinating community groundwater needs with local organizations.

**Total Number of Members:** 11

**Term Length:** 3-years

### **Description of Board Activities During 2023:**

- Completed draft report on water resources on Vashon.
  - Oversaw the monitoring of several streams and environmental education in the classroom on stream invertebrates.
  - Implemented volunteer well monitors for the safe well program.
  - Engaged and provided public education on stormwater issues in Shinglemill Creek.
  - Reviewed public health and stormwater activities on Vashon-Maury Island.

## Veterans, Seniors and Human Services Levy Advisory Board

### **Veterans Advisory Board**

**Enabling Legislation:** KC Code 2A.300.540

**Purpose/Mandate:** The Veterans, Seniors and Human Services Levy (VSHSL) Advisory Board oversees the distribution of the VSHSL proceeds for each VSHSL priority population as defined by the levy, as well as overseeing the distribution of technical assistance and capacity building funds. The entirety of the Veterans Committee of the VSHSL Advisory Committee shall constitute the entirety of the Veterans Advisory Board (VAB). The VAB advises King County on the needs of local indigent veterans and the administration of the King County Veterans Program.

**Total Number of Members:** The VSHSL Advisory Board consists of 30 members structured in three, 10-member committees. Each committee has expertise in one VSHSL priority population: 1) veterans, service members and their families; 2) seniors and caregivers of seniors; and 3) vulnerable populations.

**Term Length:** 3-years

**Description of Board Activities During 2023:**

- The Veteran, Seniors and Human Services Levy (VSHSL) Advisory Board endorsed two reallocation proposals for unspent VSHSL funds.
- The Board heard multiple presentations from King County staff on topics related to VSHSL programming, including but not limited to hiring and retention bonuses, senior programs, levy renewal, and the VSHSL Annual Report.
- The Board continued the hybrid meeting format, allowing for optional in-person participation.
- The Veterans Advisory Board conducted six meetings this year, fulfilling the annual meeting requirement.

**Washington State Major League Baseball Stadium Public Facilities District  
Board of Directors**

**Enabling Legislation:** KC Code 2.38.010

**The Washington State Major League Baseball Stadium Public Facilities District Board of Directors is considered an “Independent” board and therefore is exempt from completing the “Description of Board Activities During 2023” sections of this report.**

**Purpose/Mandate:** The Public Facilities District is an independent, municipal corporation whose responsibility it is to site, design, build and operate an excellent and attractive baseball park that is an asset to the community and the region. The PFD works both to protect and to leverage the value of this publicly owned asset on transportation, zoning, and development issues in neighborhoods adjacent to the ballpark.

**Total Number of Members:** 7 (4 King County appointments / 3 Governor appointments)

**Term Length:** 4-years

**Washington State Convention Center Public Facilities District Board of Directors  
(a.k.a. Seattle Convention Center)**

**Enabling Legislation:** KCC Chapter 2.300

**The Washington State Convention Center Public Facilities District (dba) Seattle Convention Center is considered an “Independent” board and therefore is exempt from completing the “Description of Board Activities During 2022” sections of this report.**

**Purpose/Mandate:** The Washington State Convention Center Public Facilities District board of directors shall have all the powers and duties conferred by RCW 36.100 and other applicable laws and authority and amendments thereto. The District Board’s values for operating the Convention Center include: guide the operation of the Center with quality as our foremost objective; continue to be financially self-sustaining; Generate economic benefits and other civic benefits for the people of the City, County, and Washington State; consistently provide a superior level of maintenance throughout the facility; provide a safe environment throughout the Center for clients, guests and staff; and actively participate as a partner in our community.

**Total Number of Members:** 9 members (3 appointed by King County; 3 appointed by Seattle Mayor; and 3 appointed by the Governor)

**Term Length:** 4-year term

**Washington State Boundary Review Board for King County**

**Enabling legislation:** RCW 36.93

**The Washington State Boundary Review Board for King County is considered an “Independent” board and therefore is exempt from completing the “Description of Board Activities During 2022” sections of this report.**

**Purpose/Mandate:** The Washington State Boundary Review Board for King County was created in 1967 under a mandate established by the State of Washington (RCW 36.93). The Boundary Review Board operates as an independent entity in order to fulfill its legislative responsibilities. The Boundary Review Board is funded by King County as prescribed in RCW 36.93.080. Board members serve for 4-year terms. Members are compensated at a rate of \$50 per day when conducting Board business.

**Total Number of Members:** 11 members (The County Executive and Cities of King County each appoint 4 members. Special Purpose Districts select 3 members)

**Term Length:** 4 years

---



**WaterWorks Grant Ranking Committee**  
**Enabling Legislation:** Ordinance 18031 and 18261

**Purpose/Mandate:** The Committee will review, rank, and recommend projects for funding. The committee provides increased objectivity, transparency, and resident input to the review and selection process. This committee is different from other King County boards or commissions in that the group will only be coming together every other year for formal meetings, since the grant cycle will run every other year.

**Total number of members:** 13 members (9 are nominated by Councilmembers as district representatives; 3 are filled by representatives serving on the Metropolitan Water Pollution Abatement Advisory Committee; and one seat is held by a water quality technical specialist.)

**Term Length:** 3-years

**Description of Board Activities During 2023:**

- WaterWorks staff conducted orientation and shared background information with six new committee members.
- The committee reviewed 60 full proposals, assessed proposals for fit to criteria, scored proposals, and made written comments.
- The committee then discussed proposals as a group and came to consensus decision on rank and recommendations for funding in a series of twelve meetings: 10 virtual and two in person. A final thirteenth meeting was held to evaluate the process and recommend improvements in the future.
- This thorough and objective review process ensured that the best projects were selected, maximizing water quality goals, incorporating ESJ assessments, and that the grant program was significantly transparent in decision-making and accountable to ratepayers.
- The recommendations were approved by the executive and council unanimously in November 2023, finalizing 18 grant awards for \$2.4 million.

**Women’s Advisory Board**  
**Enabling Legislation:** KC Code 2.30

**Purpose/Mandate:** The Women’s Advisory Board (WAB) meets to discuss and gather information on the needs of women and their families. As needs become known, the WAB members develop and provide recommendations to the Executive and the King County Council.

**Total Number of Members:** 15 members (9 Council district representatives; 4 Council nominated at-large representatives; and 2 Executive nominated at-large positions)

**Term Length:** 3-years

**Description of Board Activities During 2023:**

- Women’s Advisory Board members (WAB) finished the Gender-based Violence (GBV) recommendations and presented them to the public in January 2023.
- Tanya Matthews, WAB Vice Chair, presented the Gender-based Violence recommendations to the Domestic Violence Regional Task Force.

## Women's Advisory Board (Continued)

- Tanya Matthews, WAB Vice Chair, and Roxanne Thayer, WAB, presented the Gender-based Violence recommendations at the Seattle Women's Commission meeting.
  - The WAB met with over 30 contributors to form their 2022 recommendations for King County Council. These contributors included a diverse group of leaders from KC providers, DCHS, staff, and members of the community. These meetings were conducted both during WAB meetings and through individual member outreach.
  - The WAB drafted a Gender Based Violence Community Request Letter to the King County Executive in support of survivors of gender-based violence requesting to increase Mental Illness and Drug Dependency (MIDD) funding by 2 million a year, as well as requesting an additional 4-6 million in Veteran, Seniors and Humans Services Levy (VSHSL) dollars.
  - In developing their GBV recommendations, WAB ensured that their work aligns with King County's Equity, Racial, and Social Justice values.
